










Installation Diagram

Back panel install way:



Steps:

Step1: Drill holes in the wall follow the hole position on back panel.

Step2: Install and fix back panel, connect related cables.

Step3: Place M3 on back panel, fix screw at the buttom of M3.

Without back panel install way:




Steps:

Behind the wall fix M4 screws directly to the bottom shell, the depth of screws is 8mm.

This install method is unique, safe and convinient. Package list has no these screws, according to wall thickness select the length of M4 screws.







Access Control Reader & SC011




SC011 can work with M3 by Anviz encrypt Wiegand code authorized to set up a distributed access control system. You can buy SC011 from our sales.

Operation Guide

Activation:

Touch front of M3 with back of hand or fingers to activate. M3 will turn off again in 10 seconds if there are no other operations.

Enter main menu:

After activate M3, press key *** then input '0' as ID and press #, input default admin password '12345' and press # key to enter management menu.

*Pay attention: Please change to your safe admin password, because factory default password is the same, it's not safe.

Change default admin password:

In main menu, press key '0' then input new password and key # twice. (New password is 4 to 6 digits number.)

■ Programming:

User ID number: It can be 1 to 5 digital number.

User PIN code: It can be 4 to 6 digital number (To be safe, please set up 6 digital). Basic programming steps:

- 1. Activate M3, then input admin ID and password enter into main menu.
- 2. Input number to select functions and follow these operation steps:

Delete user	2	1) Swipe card: Swipe 1st Card→swipe 2nd Card→swipe 3rd Card→+"#" 2) User ID: Input 1st user's ID→Input 2nd user's ID→+"#" 3) All Users: Input 0000+"#"		
Verify mode to open door	3	1) Card or PIN code(Factory default): Input 0+"#" 2) Card: Input 1+"#"		
Delay time of electric lock	4	Input 0 to 30 +"#" to set lock dealay time.(Factory default: 5 Seconds)		
M3 work mode	5	1) Access controller(Factory default): Input 0+*#" 2) Reader: Input 1+*#"		
Door magnetic	6	1) Turn off door magnetic function(Factory default): Input 0+"#" 2) Turn on door magnetic function: Input 1+"#"(In this mode, if door was opened over 15 seconds, the buzzer in M3 will ring.)		
Tamper alarm	7	1) Turn off tamper alarm function(Factory default): Input 0+"#" 2) Turn on tamper alarm function: Input 1+"#"(In this mode, if M3 was disassembled, the buzzer in M3 and external alarm will ring.)		
Reset to factory defaults	9	Input 000 ""#" (When you want to delete all the registered administrators and users and let M3 back to the factory default settings, you can reset it.)		

*Pay attention:

Multifunctional key "*": return to previous.

3) PIN code verify operation: After activate M3, input ID + "#" key firstly, then input right PIN code + "#" key, the door can be opened.

LED & Buzzer status

Status	LED	Description	Buzzer
1	Blue LED lights and number keys light	Activation status.	Buzzer not ring
2	Green LED lights	Register or verify or delete user such as these settings successfully	One Beep
3	Red LED lights	Register or verify or delete user unsuccessfully or register capacity > 50,000 cards	Three Beeps
4	Blue LED flashes	Enter main menu	Buzzer not ring
5	Dide EED Hashes	Enter register or other operation mode	Buzzer not ring
6	Blue light always lights	Tamper alarm rings	Long Voice

■ Working with Management Software


1. Install the Management Software on Computer

Please download the CrossChex Software from our website: http://www.anviz.com/en-us/product/Index/category/51.html. Then install it on your computer, run the main interface as follows:




How to connect M3 with Software?

1st Method: Mini USB



- Loose the screw on the bottom of M3, then pull up the front case, separate from back panel
 - Connect USB cable between with M3 and PC which has installed software

2nd Method: Connect M3 to Network



2. Enable Communication between M3 and the Management Software CrossChex

*Turn on management software CrossChex

*Go to Device tab. Search and Add the M3 to management software CrossChex

*Click Synchronize Time button to communicate with M3. If Synchronize is successful, the device icon will turn to blue.

3. The Management Software CrossChex Features

*Device\Backup User: Download user info from M3 to CrossChex

*Device\Download Records: Download records from M3 to CrossChex

*User\Modify: Edit name or other user info. Then click

'Upload User' to Upload user info to M3 device

*Record\Search: Search and view the records

*Attendance: Calculate, Search results and Generate reports

*Data\Backup Database: Backup Database

*Setting\Shift: Set up Time Table and Scheduling

*Device\Device Parameter: Set up device, Clear records on M3 or Reset M3 to factory settings
